Approval of minutes: Jim Zvolanek motioned to approve the minutes dated April 12, 2022, Tom Wilkinson 2nd. Motion carried.

Treasurer's report: Michelle Schwerdtfeger motioned to approve the treasurer's report dated April 2022, Greg Tripp 2nd. Motion carried.

Karen Bonar from the Ellsworth County Independent Reporter introduced herself to the council.

Old Business:

- Water Project Thaniel Monaco sent an email with an estimate to repair well #8. Quote was from ESI for \$8963.00. Mayor Hopkins thought Yost Electric was going to bid the project. Mike Bunch to said that Yost Electric thought it would cost about \$3500.00. Mike to call Yost Electric Wednesday morning. Mayor Hopkins said he would still like to have a walk through at well #8.
- Abatements Demolition can begin at 304 S Colorado. Judge Svaty ordered the city to send a letter stating the date that the city would begin brining the property at 420 S lowa into compliance. The city attorney is to draft a letter to the owner on the city's behalf.
- Drinking Water Protection Plan This was tabled.
- Audit Bids Debbie Kralik contacted Varney & Associates in Manhattan, Gudenkouf & Malone in Russell, and Adams Brown in Great Bend. Debbie only received one response From Adams Brown. The other two audit firms declined. Jim Zvolanek motioned to accept the bid from Adams Brown for \$10,750.00 for the first year, \$10,965.00 for the second year and \$11,180.00 for the third year, Tom Wilkinson 2nd. Motion carried.

➤ Street Sealing – Greg Tripp received bids from Circle C Paving for \$85,907.00 to chip seal approximately 31,239 square yards and South Central Sealing & Paving for slurry sealing for \$83,016.48 for 28,528 square yards. The difference is no dust and no loose rock with slurry sealing. Slurry sealing seals cracks better but does not build the road base because they use ground rock. The streets must be blocked off for about 3 hours with slurry sealing. Tom Wilkinson motioned to approve the bid from South Central Sealing & Paving for \$83,016.48, Greg Tripp 2nd. Motion carried.
