The council of the City of Kanopolis met for hearing abatements on April 11, 2023, at 5:25 p.m. at the Kanopolis City Hall.

Kathy Sneath wants to know what the council is complaining about now. She said that there are worse places in town. Mayor Hopkins told Kathy that they have been trying to get this property cleaned up for several years. One of the items on the property is the RV that is untagged & has no insurance. Kathy explained that she is working on getting that removed. Mayor Hopkins said that the council is willing to work with her to get the property cleaned up. Tom Wilkinson said that he understands that it is a huge undertaking, but the council would like to see progress. Mayor Hopkins said that the council would rather see the homeowner correct the issues instead of abating the property. Kathy asked for 1 year to get things up to par. Mayor Hopkins said we cannot allow 1 year for progress. Mayor Hopkins said that they will give Kathy until the June meeting & if there is significant progress, will allow more time at that meeting.

## New business:

- ➤ Community Center Debbie Kralik was contacted by Kansas Gas Service regarding the lines going into the community center. They will be moving the gas lines from underground to above ground. There will be no expense to the city. Debbie also told the council that she had to call City Plumbing about an issue with the heaters. Randy Kempke got one of the heaters to work, which was enough for that day. City Plumbing sent a quote for 2 new heaters & air conditioners for \$22,000.00. City Plumbing wants to take the heaters out of the ceiling & put them in a small closet on the main floor. Mayor Hopkins asked Debbie Kralik to solicit more bids before the next meeting.
- ➤ World Pest Control annual spraying Debbie was contacted by World Pest Control regarding the annual spraying of city buildings. The cost is the same as last year for \$330.00. Michelle Schwerdtfeger motioned to approve the bid for \$330.00 for World Pest Control, Jim Zvolanek 2<sup>nd</sup>. Motion carried.
- Employee Pay Raises effective 4/30/23 Michelle Schwerdtfeger motioned to go into executive session to discuss 1 or more employees wage & salary for 10 minutes to return at 6:07, Jim Zvolanek 2<sup>nd</sup>. Motion carried.
  Meeting reconvened at 6:07. Jim Zvolanek motioned to approve a 3% pay raise for all full-time & part-time employees, Michelle Schwerdtfeger 2<sup>nd</sup>. Motion carried.
