Approval of minutes: Levi Schneider motioned to approve the minutes dated August 12, 2025, after amending attendees to include Drew Miley & Rebekah Tripp, Drew Miley 2nd. Motion carried.

Water Project – Thaniel Monaco emailed & said that he has been coordinating with the contractor. The contractor is preliminarily planning to start the watermain work later this month or first part of October. They plan to have the watermain materials ordered and delivered to the site by the end of the month. You should expect to receive your first pay request for your October meeting.

New Business:

- ➤ New Utility billing software Debbie Kralik received a quote from Thoroughbred Utility Billing Software to replace gWorks. She said that she has had nothing but problems with the gWorks software including charging a customer's card at least 18 times, changing the city to Kanopolis for all of the out of town bills & the lack of reports available. Jim Zvolanek motioned to approve changing to Thoroughbred Software, Levi Schneider 2nd. Motion carried.
- ➤ Temporary New hire Debbie let the council know that she received 3 applications for the temporary maintenance position. Mike Bunch said he thinks it's a waste of time because mowing season should be over in about 3 weeks. Mayor Schwerdtfeger asked if there was a need for a 2nd maintenance person if he could handle everything himself, Mike said yes because he can't run a backhoe & crawl in the ditch at the same time. Drew Miley suggested tabling the hiring until we know more about Aaron's situation. The council asked Debbie to contact the applicants to let them know the hiring process has been tabled.
